Seychelles SFPA

On 24 February 2020, the European Union and the Republic of Seychelles signed a new 6-year Sustainable Fisheries Partnership Agreement (SFPA) and associated implementing Protocol setting out the fishing opportunities for EU vessels, the financial compensation to be paid by the Union and the modalities of sectoral support to the fishing sector of the Seychelles. The current Protocol covers the period 24.02.2020-23.02.2026 with an EU financial contribution of €5.3 million per year, out of which €2.8 million is earmarked for the support of the fisheries policy of Seychelles.

This fisheries agreement allows EU vessels from Spain, France, Italy and Portugal to fish in the Seychelles' fishing zone and is part of the tuna network fisheries agreements in the Indian Ocean.



Main target species

The 2020-2026 Protocol provides for fishing opportunities for 40 tuna seiners and 8 surface longliners. The seiners and pole-and-line vessels are targeting yellowfin tuna (*Thunnus albacares*), bigeye tuna (*Thunnus obesus*) and skipjack tuna (*Katsuwonus pelamis*).

The composition of bycatch should be in compliance with the current regulations from IOTC and the FAO recommentations.

Landings by foreign operators

According to the Protocol, EU vessels are not obliged to land their catches in Seychelles, but they are encouraged to do so by the Parts.

The designated port for landings is the port of Victoria (Mahé). The following table shows the total landing and transshipment in Port Victoria by purse seine vessels licenced to fish in Seychelles' waters for 2019 is summarised below (in t), disaggregated by Flag State.
